Public Bank (Hong Kong) is committed to corporate social responsibility in manpower development with Training and Development Department organized 1-day educational program for a batch of United Christian College Secondary Students on 3 March 2015 at the Bank's premises.

This educational program introduced to the students an overview of the banking industry in Hong Kong and also helped them explore careers in the different professions of the banking industry. Experienced managers from various departments giving a briefing to these students about their nature of work and invited them to walk through the work process. A Senior Management staff was also invited to share his experiences in managing the Bank's network of branches.

At the end of the program, the students found the program meaningful and informative as it provided an opportunity for them to learn about the operations of a bank and what it was like to perform a certain type of job at the workplace of a bank. This learning experience would help them prepare for their future career planning.

Staff of Public Bank (Hong Kong) participated as volunteers together with other bank's volunteers in the Hong Kong Association of Banks (HKAB) "Youth Financial Education Programme 2015" to promote financial literacy and life planning concepts to the youth in Hong Kong in a fun, interesting and interactive way through a number of activities and events. Two of our staff, Mr Eric Lam and Ms Jessica Fong from Training and Development Department signed up as volunteers to support this meaningful programme.

The 1st event of the programme was the "Financial Literacy Workshop" held on 11 June 2015 attended by college students. The aim of this workshop was to provide training to a team of 30 students from different colleges in becoming Young Financial Ambassadors. Mr Eric Lam, together with other volunteers, acted as one of the mentors and group leaders in this workshop who shared their career stories, financial management and life planning experience with the Young Financial Ambassadors. The workshop gave them new insights for their future development and career planning.

The 2nd event of the programme called "Life Journey Financial Experiential Session" will be held in October 2015 for another group of secondary students. Ms Jessica Fong, together with other bank volunteers, will act as activity leaders to guide the students during the Experiential Session.

Participation in HKAB Youth Financial Education Programme 2015: Life Journey Experiential Session 香港銀行公會舉辦:青年理財教育計劃 2015 - 生涯規劃理財體驗

Public Bank (Hong Kong) continues to commit to corporate social responsibility in the training and development of youths in the local community by participating as volunteers together with other banks in the "Youth Financial Education Programme 2015: Life Journey Experiential Session" organized by HKAB. The session was held on 15 Oct 2015 to promote financial literacy and life planning concepts to secondary students from Concordia Lutheran School in a fun and interactive way through activities.

During the experiential session, Ms Jessica Fong, a staff from Training & Development Department, acted as one of the activity leaders in guiding the students. In the activity, the students played different roles in their various stages of life such as a student and a worker role within a 5-year period. In their roles, they have the choice of freedom in furthering their studies in the university, working, spending on consumer goods, gambling and investing. Whatever expenses incurred in their choices and their experiences were recorded in a book which was given to them before the activity.

在理財體驗活動中,本行培訓及發展部同事Jessica Fong擔任指導學生的領導員之一。在活動當中,學生們可於5年時間內體驗不同的生活階段,扮演不同的角色如學生和工作者。在自己扮演的不同角色當中,他們可自由選擇升讀大學、工作、消費、賭博和投資等。所有因自己作出之選擇而衍生的任何費用和經驗,均須記載於早在活動前派發給他們的書本上。

The activity leaders also shared their own career stories and financial management with the students. At the end of the day, the students commented that they benefited from the activities by learning from the life experiences of the different roles they played and the sharing of experiences by the activity leaders.
